## MAKE SURE THE JOURNAL REACHES YOU

This is the last issue of the *ICCA Journal* to appear in 1991. Your membership has formally expired by December 31, 1991. In 1991 you should have received four Journals as due to you under your membership. In order to receive the 1992 Journals, you should subscribe as an ICCA member. The (renewal) fee is now Dutch florins (Hfl.) 50.--, or US \$ 30.-- for those residing in North America. This annual fee is valid for the year 1992 and has been confirmed for the period 1990-1992 at the Triennial Meeting in Edmonton, Alberta in June 1989. Below we discuss the *European* money-transfer possibilities.

We stress that the fee ought to be *net* to ICCA, that is, our credit booking, free of all banking charges. However well intentioned they may be, we often receive checks to the amount of Hfl. 50.-- (or equivalent) on which *we* are charged for banking fees (transfer commission or execution commission). Since these currently amount to a third of the subscription rate, they are unacceptable. Hence we stress that when remitting, you state the amount to be paid in Dutch guilders *net*. This can be effectuated most easily by sending us a Eurocheque or Postal Order (with charges to you). In any case, state the amount in Dutch guilders please.

Although there is a minor risk, we also accept banknotes forwarded to us by post delivery. It is a primitive but effective way of paying your dues and a perfect way of transferring your dues net and *free of all charges* to what is after all your own ICCA.

To sum up, the possibilities of paying the renewal fee are (1) cash Hfl 50,-- (2) Eurocheque Hfl 50,-- (3) Direct Bank transfer Hfl 65,-- (4) all other cheques Hfl 70,--
