### Fourth International Isokinetic Workshop Washington DC, June 24th 1995

Minutes of business meeting

#### **Treasurer's report**

Sheila Strover confirmed that the Society had received £3200 from subscriptions and £2683.26 from manufacturers in support for ISCI meetings. However, the cost of putting together the Washington Workshop had been high. There would be a deficit at the end of the meeting. Angus Strover had agreed to underwrite the deficit.

#### **Chairman's report**

Angus Strover assured members that the Society would continue to promote its aims, namely independence from the trade and the production of objective academic data. The Society would have its own policies for isokinetic evaluation and treatment. The Society would continue to promote research and teaching and to encourage a truly international membership.

There was a need to encourage more orthopaedic surgeons to become directly involved with isokinetics. Angus Strover suggested that isokinetic measurements could be taken pre and post surgery to evaluate the effectiveness of the surgical procedure.

The Society was still without a formal constitution. A draft constitution was circulated to all delegates and Angus Strover encouraged members to come up with suggestions. The ISCI committee would work together to finalise the constitution and with help from the membership would hope to present a new draft for the next AGM.

#### Any other business

There was no other business.

#### Date and place of next meeting

Suggestions were made to hold the next meeting in conjunction with a Physical Therapy meeting. No particular meeting was identified, but it was suggested that we should try for a meeting in Europe in October or November 1995. Alternatively a meeting would be planned for Spring '96.

The committee are already in discussion with the French isokinetics association (Gedri) with a view to setting up a joint meeting in 1997.

The meeting closed at 6.30 pm.

The International Society of Isokinetics held its fourth International Isokinetics Workshop in Washington DC on June 24th 1995. The Workshops were held just prior to the WCPT Congress which took place in Washington the following week. The Workshops were held at the Stouffer Mayflower Hotel which was indeed a splendid venue.

Committee members of ISCI were disappointed at the number of American delegates who applied to attend the Workshops. Despite sending hundreds of flyers to Biodex, Cybex and Chattanooga for distribution to their users and holding the meeting immedi-
